



Revenue & Expenses


AYSP 2023-2024 Revenue



AYSP 2023-2024 Expenses







AYSP Land Acknowledgement

AYSP serves children, youth and families across the Peel, Halton, Dufferin and Toronto Regions situated on the territories of the Anishinabek (An-ishinabek), Huron -Wendat (Her-on - Wen-dat), Haudenosaunee (Hoed-eno-shownee), Ojibway (Oh-jib¬way)/Chippewa (Chip-peh-wah), the Mississaugas of the Credit, Wendake- Nionwentsïo (When-dah-kee / Nye-on-went-see-oh), Attiwonderonk (At-ti-wan-da-ronk), and Tionontati (Tee-oh-nahn-tah-tee) peoples.

These areas are covered by Treaty 13: the Toronto Purchase Treaty, Treaty 19: the Ajetance Treaty, the Haldimand Deed of 1784, and Treaty 18: The Nottawasaga Purchase. Indigenous peoples in past and present generations have nurtured and cultivated this land, the land where we live and work.

We acknowledge our Canadian history as a part of Turtle Island involves settler colonialism and oppression of Indigenous peoples. Within the helping profession we acknowledge the specific impact of oppression of Indigenous children, youth and families in our regions and those that we service.

The Truth and Reconciliation Commission has published 94 calls to action to respond and to recognize the rights of the original and current Indigenous inhabitants of the land. We invite all to reflect on one's personal accountability and how to engage in action towards the decolonizing of Indigenous peoples, communities and land.

AYSP Volunteers

The Volunteer Program at AYSP remains steadfast in its commitment to supporting our organization's programs and our volunteers continue to play a pivotal role in service delivery. Throughout the 2023-2024 fiscal period, our volunteers have demonstrated unwavering dedication and passion in their efforts to make a positive impact on the lives of our clients and the community as a whole.

Our volunteers can be found actively engaged in various aspects of AYSP, including facilitating one-to-one life skills programming for clients, leading Youth Justice Committee circles and providing group support to our DBT (Dialectical Behaviour Therapy), TREE (Tolerating and Regulating Emotions Effectively), YBB (Youth Beyond Barriers) and Triple P (Positive Parenting Program) programs.



We were thrilled to welcome 13 new volunteers to the Peel Volunteer team, onboarded and trained during our Spring Volunteer Recruitment in April and May. These volunteers each bring their own unique skills and perspectives to holistically enrich AYSP's programs and services.



In recognition of their invaluable efforts, the Volunteer Program hosted two appreciation events during the fiscal period. The first event, held in April in conjunction with National Volunteer Week 2023, was an opportunity to celebrate our volunteers' dedication and commitment. During this event, we also had the privilege of presenting Years of Service awards to those volunteers who have dedicated 2, 5 and 10 years of service to AYSP. Our second event, held in November, further fostered a sense of community and team-building among our volunteers, strengthening our collective resolve to make a positive impact in the lives of children, youth and families.





Furthermore, our volunteers have actively pursued opportunities for professional development to enhance their skills and expertise. Several training sessions were conducted throughout the year, including the Non-Violent Crisis Intervention Training facilitated by the Canadian Training Institute, as well as program facilitator trainings for our Employment Readiness, CHOICES, Anger Awareness and SMART Programs. These trainings not only empower our volunteers to better support our clients but also underscore their ongoing commitment to personal and professional growth.



Behind the scenes, our Volunteer Advisory Committee has also played a pivotal role in ensuring that the voices of our volunteers are heard and valued throughout the agency. Their dedication to advocating for the needs and interests of our volunteers reinforces our commitment to fostering a supportive and inclusive environment for all within the Volunteer Program.





The Volunteer Program has also been involved in the formation of AYSP's internal Youth Engagement Committee. In November, we onboarded and trained 12 youth volunteers from the Peel region to join our Youth Engagement Committee.
